Minutes of the 8th Monthly Review Meeting of NMEICT Phase-II & e-Shodh Sindhu (eSS) was held under the Chairmanship of Secretary (HE), MHRD on 24.10.2019 in Room No. 127, C-Wing, 1st Floor, ShastriBhawan, New Delhi

The 8th Monthly Review Meeting of NMEICT Phase-II & e-Shodh Sindhu (eSS) was held under the Chairmanship of Shri R. Subrahmanyam, Secretary (HE), M/o HRD on 24.10.2019. The list of participants is at Annexure. The major decisions / action points emerged are:

National Digital Library (NDL)

- Funds Requirements: PI, NDL brought to notice of the Committee about the non-availability
 of funds for the project. Secretary (HE) directed that all efforts will be made by the TEL
 Division, M/o HRD to meet the projected funds (total Rs. 22 Crore) requirements of the
 project for the F.Y. 2019-2020. It was informed by TEL division that case for release of
 Rs. 4.0 Crore has been processed and is under examination by IFD, M/o HRD.
- NDL utilization: NDL to provide detailed report on the total downloads (subject wise) for 2017-18,2018-19 & from April 2019 to October 2019, for students from various categories of Universities (CU; State; Open; private..) and students from school (Class10-12 &below class 10)
- NDL Clubs: NDL to identify "the best club(s)" & "the best success stories" related to the current NDL clubs in increasing the reading habits of the students.
- 4. <u>Pilot Project "Collaboration with e-Learning Organization & Entrepreneurs"</u>: It was agreed that this project can be undertaken under NEAT, if same is found to be fit to be undertaken under NEAT by the NEAT's Expert Committee.
- Integration of SWAYAM & NDL: It was informed that SWAYAM team (IIT,Madras)has suggested that this will be undertaken immediately after complete system is migrated to Google Cloud.
- e-Books (Permanent Repository for NDL from World e-Book Library): Joint Secretary (TEL), MHRD suggested that from WEL resources, text books which are mostly used by major Universities & Institutions for their Undergraduate courses (B.A./B.Sc./B.Tech), may be identified and sourced as permanent resource.

ERP (SAMARTH)

- 7. The committee appreciated the progress made by the Project Team in rolling out different modules / packages by the Project Team. Chairman directed that access to the beta version & final version of the "dashboard" indicating activities & status of implementation to be provided to MHRD on priority.
- 8. Project team to submit "Implementation Summary Report" to MHRD indicating status of implementation of various modules in various CUs.

e-Shodh Sindhu (eSS), IRINS& Plagiarism Detection Software (PDS)

- Committee was briefed about various activities being undertaken for ESS, including review by NSC of ESS. Further formulation of an expert committee to formulate the revised model for ESS, which will be effective from CY 2021, was deliberated. INFLIBNET to inform the constitution & TOR for the same.
- 10. The usage of PDS by various institutions/Universities was deliberated. It was informed that the "overseeing" committee will be meeting on 15th Nov 19, for reviewing the Utilisation visà-vis categories of Users & documents. To make it more popularize, INFLIBNET may conduct awareness capsules.
- 11. Regarding IRINS, Chairman directed to make it more effective and with more analytic features. Design/Architectural Review may be conducted at the earliest.

BAADAL

- 12. PI, BAADAL informed that current infrastructure has already reached its "End of Life" and also it does not support the new features & capabilities of "Cloud" infrastructure. It was decided that for time being the existing BAADAL may be supported to the existing users of BAADAL.
- 13. The project team to provide "BAADALUtilisation report" for various applications/services/users for 2017-18, 2018-19 & from April2019 to October 2019.

Virtual Labs

- 14. PI, Virtual Labs informed the committee about various activities to enhance popularity and usage of Virtual labs being undertaken by various Nodal Centres of the Project.
- 15. Chairman desired that PI to submit "VL Utilisation report", Nodal Centre wise, indicating number of Experiments and number of the students for 2017-18, 2018-19 & from April 2019 to October 2019.
