Minutes of the review meeting of the Project e-Yantra under Scheme NMEICT held on 10.01.2020 at 4.00 p.m. in the chambers of Addl. Secretary (TE).

Prof Kavi Arya, PI made a presentation on the project. E-Yantra is a project undertaken by IIT Bombay for enabling effective education across engineering colleges in India on embedded systems and Robotics. The training for teachers and students is imparted through workshops where participants are taught basics of embedded systems and programming.

- 2. AS (TE) appreciated the efforts of the e-Yantra team.
- 3. The PI briefed about the outreach activities they have been doing across the country and requested for MHRD intervention in case of Bihar & Jharkhand specifically as they have found quite a challenge to establish e-Yantra labs in their colleges. As of now, they have established 370 labs across the country. The PI said that the notable achievement of the e-Yantra competition is that the students learn practical skills and application of embedded system, gain confidence and team work. Their higher order thinking skills improve tremendously through these competitions. Thereafter following decisions/action points emerged:

 - 2. Data on the number of labs (eLSI) established and functioning in the AICTE colleges, TEQIP institutions, IITs, IIITs, NITs, IISERs and polytechnics separately may be compiled. MHRD will write to respective authorities to establish e-Yantra lab. A draft letter shall be suggested by PI to MHRD.
